- Strengthen club revitalization and volunteer engagement
- Increase accessibility and welcome new riders into the sport

Applications will be accepted online from **April 1 through July 31, 2026**, with funding decisions announced by **September 15, 2026**. Organizations with previously submitted but unfunded proposals are encouraged to apply again.
